**All teams are encouraged to participate in the "People's Choice Competition" on Saturday, and the Friday Night Tasting event to allow the public to sample your culinary expertise.** Friday Nights Tasting event will have four categories of Sauce, Salsa, Beans and Anything Goes. These can be prepared off site, and cooked before you arrive as this is not a KCBS event, but a charity event. Each Category for the Friday Night event is \$10 to enter. All contestants will turn in their food to one location for public consumption. All pans, plates, etc., will be provided to you. If you are interested in the Friday Night Event, please download the Friday Night Application. Saturday "People's Choice" meat will be provided to each contestant who wishes to participate. Each team will be provided with (1) volunteer to assist with the promotion and distribution of your "People's Choice" entry. Again, all pans, plates will be provided to you. "People's Choice" winner will receive \$300 Cash.

Competition grounds will be open on Friday October 9 at 10:00am. There will be no movement of vehicles in the competition area between the hours of 5pm-11pm on Friday (with the exception of late arrivals) and 9am-4pm on Saturday.

Cook's Meeting will be on Friday, October 9, 2009 at 7:00pm.

The contest will begin on Saturday, October 10, 2009 with turn in times beginning at 11:00am for People's Choice, 12:00pm for Chicken, 12:30 for Pork Ribs, 1:00 for Pork, 1:30 for Beef Brisket, 2:00 for Anything Goes. Awards will begin at 4:00pm or as soon as the judging is completed.
